INTRODUCTION AND ANNOUNCEMENTS

The meeting commenced at 12:25 p.m. conducted by Chair Dan Eldredge. Mr. Eldredge welcomed everyone to the meeting. He stated the RCCC has a quorum to conduct the business before them. Mr. Eldredge had the RCCC members and visitors introduced.

ROLE OF THE RENEWAL CONTRACT COORDINATING COMMITTEE PRIOR TO THE TRANSITION DATE

Mr. Eldredge reviewed with the RCCC members the Renewal Contract Coordinating Committee document including Purchasers who are parties to the Renewal Power Sales Contract; it is formed and governed by Section 6.1 of the RPSC's; and the Committee is similar to the Original Coordinating Committee with few exceptions.

Mr. Eldredge reviewed with the RCCC members the RCCC Organization includes individual representatives appointed by each California Purchaser and each other Purchaser with 1.4% Generation Entitlement Share under the RPSC; collective representatives elected by the remaining Utah Municipal Purchasers and Cooperative Purchasers; the Chairman, IPA General Manager; Organized within the period required by RPSC's; and recommendations proposed to be developed for bylaws and organization of subcommittees.

Mr. Eldredge reviewed with the RCCC members the key RCCC dates including Effective Date - January 16, 2017; Entitlement Determination Date - January 17, 2017; Deadline for Organizing RCCC - February 16, 2017; Date after which financing can proceed- November 1, 2019; Date of Commencing Operation - July 1, 2025 of the Gas Repowering under the Power Sales Contracts; and Transition Date - June 16, 2027.

Mr. Eldredge reviewed with the RCCC members the RCCC role prior to the Transition Date; and the project indebtedness prior to the Transition Date. Mr. Eldredge also discussed the required approvals prior to the Transition Date for the RCCC members.

Ms. Thomas from Pasadena asked for a copy of this presentation to be sent to the RCCC members.
